PM Lays the Foundation Stone for the Development of Deoghar Airport

PM Modi Inaugurates NTPC's Patratu Thermal Power Plant in Jharkhand



Prime Minister Shri Narendra Modi laid the foundation stone of the first phase of 2,400 Megawatt (MW) capacity of NTPC's Patratu Super Thermal Power Project in Ramgarh district, Jharkhand.

The project is a 74:26 Joint Venture between Government of Jharkhand and Patratu Vidyut Utpadan Nigam Ltd., a subsidiary company of NTPC establishing a total capacity expansion of 4,000 MW.

A senior NTPC executive said the first phase of the project will be set up at an estimated cost of around Rs 18,000 crore. The Patratu project is a Joint Venture with 74 per cent stake of the Jharkhand government and Patratu Vidyut Utpadan Nigam Ltd's 26 per cent stake. Jharkhand Governor Droupadi Murmu, Chief Minister Raghubar Das, Union power minister R K Singh were among those present on the occasion.

PSBs' Rising Bad Loans

The Reserve Bank of India's bi-annual financial stability report released on June 26 shows that banking sector's bad loan problem continues to worsen despite the government prodding lenders to expedite recovery and clean up balance sheets.

The bulk of bad loans is owed to public sector banks (PSBs). Rising burden of dud loans could force PSBs to step up provisioning, which could in turn dent their profits and hamper efforts to bolster capital base.

This also does not augur well for revival in credit off-take, which is urgently needed to support the economic recovery.

This banking crisis could also complicate political challenges for the Modi government given that general elections are due early next year.

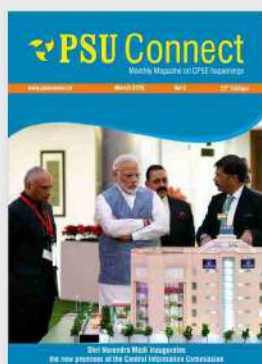
Specifically, the report has expressed fear that banking sector's gross NPA ratio of banks could rise from 11.6% in March 2018 to 12.2% by the end of the current financial year.

For the 11 state-owned banks under prompt corrective action framework (PCA), the GNPA ratio could increase from 21% to 22.3% during the same period. Six could experience capital shortfall relative to the required minimum CRAR (Risk-weighted Assets Ratio) of 9%.

The 11 banks under PCA framework are IDBI Bank, UCO Bank, Central Bank of India, Bank of India, Indian Overseas Bank, Dena Bank, Oriental Bank of Commerce, Bank of Maharashtra, United Bank of India, Corporation Bank and Allahabad Bank.

The government is looking at handing over NPA-hit IDBI Bank to Life Insurance Corp. However, the idea has its own critics. IDBI Bank has the highest NPAs among all PSBs. To many, transferring toxic assets of state-owned to the public insurer hardly makes sense.

Hyderabad Gas Pipeline to be Commissioned by 2020



The Paradeep – Hyderabad gas pipeline being constructed at a cost of Rs. 2321 crore would be commissioned by 2020. Shri Subhodh Dakwale, Executive Director and All India Head for Corporate Communications and Branding, Indian Oil Corporation Limited said in a Press Conference, IOCL would be expanding in the next two to three years investing about Rs. 3000 crore. Land acquisition for laying the pipelines from Paradeep – Vizag – Vijayawada – Suryapet, Hyderabad is almost over, he said.

A green field project with a cost of Rs. 320 crore would be taken up in Vizag soon. In Telangana, IOCL would be setting up a new oil terminal investing Rs. 500 crore, he said, Terminals would also be set up in Thimmapur and Charlapalli in Telangana. The capacity of terminals at Vijayawada and Vizag will be augmented at a cost of Rs. 316 crore.

Govt Orders out of turn Coal to PSUs



The government has advised Coal India Ltd to make 'out-of-turn' allotment of scarce coal to central and state electricity generation companies.

In a May 24 communication to Coal India, the Coal Ministry said there may be an increased demand for coal due to a surge in demand during peak summer.

Alternate Plans are being Worked out to Meet Short supply: IOCL Chairman



IOCL has indicated that fuel prices could go up further as it was difficult to predict how the crude oil supplies from Iran could shrink and impact India's oil economy, IOCL Chairman and Managing Director Sanjiv Singh said recently.

Disclosing the audited financial results of the company for FY 2017-18, Shri Sanjiv Singh said the short supply of about 6 to 7 million tonnes from Iran, which is what India imports from the country, could definitely impact supply demand chain and prices. "We have not yet received any clear cut directive from the government on the Iran situation, we are working out alternate mechanism for making up the shortfall, he said even as the petroleum minister Shri Dharmendra Pradhan had convened a meeting of all CEOs of national oil companies to discuss the supply demand situation and impact on prices.

The IOCL Chairman also indicated that the company would desire that all petroleum products are brought under the GST regime so that a uniform pricing is maintained for petroleum products. For instance in Maharashtra prices of fuels spurted to Rs 80 a litre while it was around Rs 75 a litre elsewhere because Maharashtra gambled on low fuel prices and raised the excise duties which pushed up prices as global crude oil and POL prices suddenly soared.

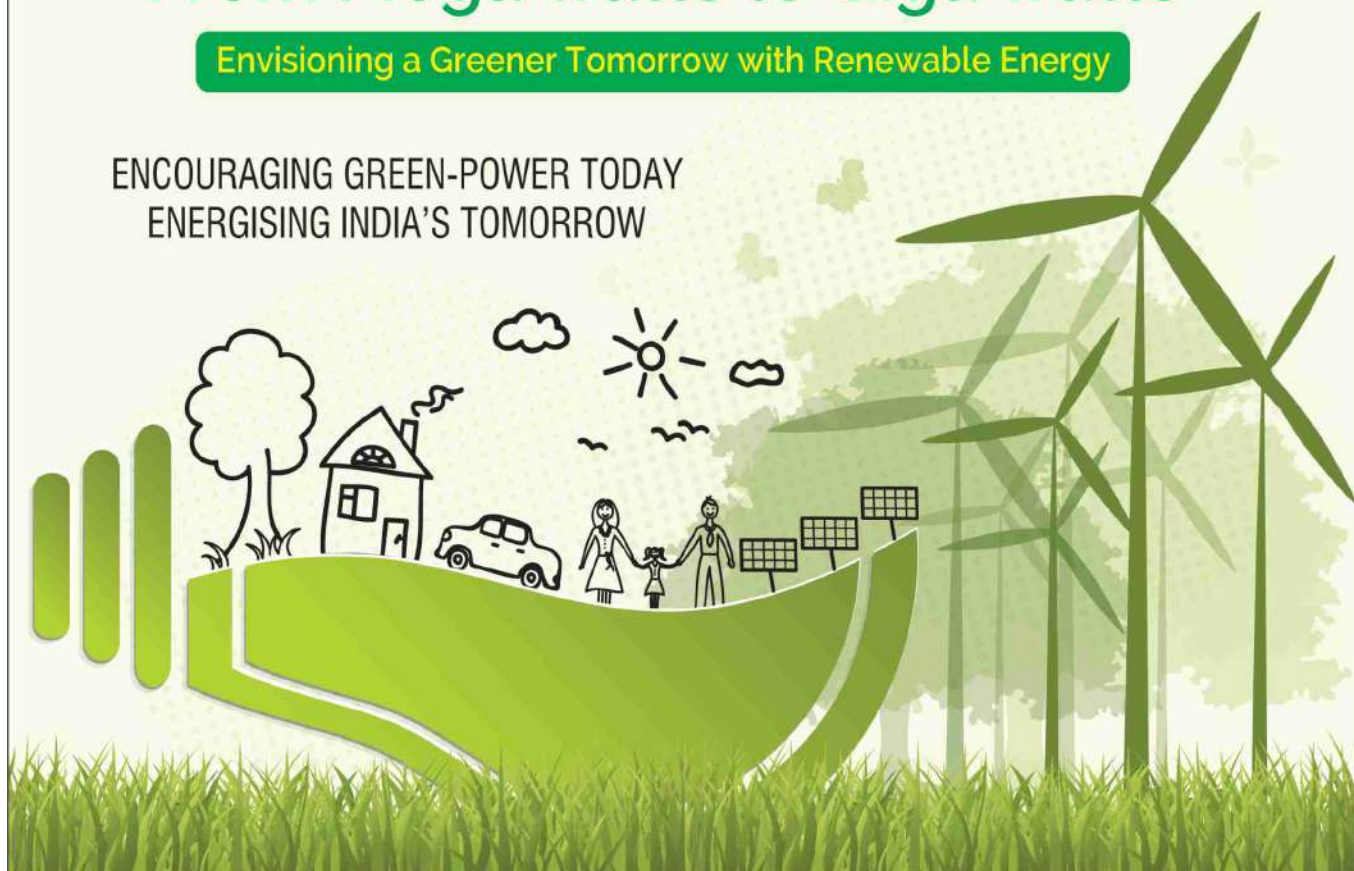

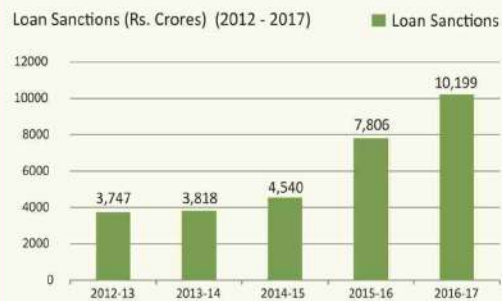
